**School of Teacher Education**

■ Proposal to Revise a Program – the revised policy will apply to all undergraduate programs leading to teacher certification in elementary education, middle grades education, secondary education, exceptional education, and interdisciplinary early childhood education.

There was a Berger/Maxwell motion to approve/second. Marge Maxwell and Retta Poe presented. After some discussion the motion passed.

It was agreed to address the following two proposals together

■ Create a Temporary Course – ELED 572, Math and Technology Methods for Diverse Learners

■ Create a Temporary Course – ELED 573, Math and Technology Assessment and Intervention

There was a Carter/Hughey motion to approve/second. Marge Maxwell presented. The motion passed.

**Educational Leadership Doctoral Program**

■ Create a New Course – EDLD 800, Maintain Matriculation

There was a Berger/Maxwell motion to approve/second. Retta Poe presented. There were some questions raised.

The motion passed with the understanding that Retta will talk with Tony Norman and get some clarification on two issues raised.
