Admission and Retention Subcommittee
June 3, 2016
Minutes and Report to PEC for June 8, 2016 Meeting

The Admission and Retention Subcommittee met electronically in May 2016 to hear one student appeal for an Elementary Education student, KV, asking that an exception be made for admission to professional education based on student's GPA in the last 30 hours of course work.

The Admission and Retention Subcommittee was made up of the following PEC members: Dr. Lauren Bland, Ms. Rachel Leer, Dr. Janet Tassell, Dr. Fred Stickle, and Dr. Janet Applin as chair. The committee received information from the student and from teacher services regarding the student's appeal.

The committee voted to recommend that an exception be made and the student be allowed admission to professional education provided all other teacher admission materials are completed. The student has also been informed, in writing, that all student teaching requirements must be met before approval for student teaching will be granted.

The committee recommends that the full PEC accept the recommendation and allow the exception for admission to professional education for this student.
