New Business

Office of Teacher Services-CEBS

▪Presentation of Candidates Completing Requirements for Admission to the Professional Education Unit April 10, 2013 to May 8, 2013

▪Proficiency Evaluation

Section 1 of 16 KAR 5:030 Proficiency Evaluation provides opportunities whereby an Institution may evaluate and accept competency for teacher certification purposes for any of the specific curriculum requirements when the teacher candidate can demonstrate proficiency by reason of previous education, unusual experience, or proficiency examination at a level comparable to the usual requirements in that curriculum area. Ellen Gott provided copies of a memo from the Director of the STE and endorsed by the Director of Teacher Services, recommending that Dr. Edward N. Howell be admitted to professional education and recommended for teacher certification for Music: Integrated, P-12. These recommendations were made in accordance with the Policy on Recommending Teacher Certification Based on Proficiency Evaluation.
