The minutes from the August 14, 2013 meeting had some revisions mentioned. Lauren Bland informed the Council members that the name of their department is now Department of Communication Sciences and Disorders. She also stated that they would prefer to have the wording changed in the minutes to say the following: A request was made that the Department of Communication Sciences and Disorders students to be deferred until the September PEC meeting and faculty in the Department of Communication Sciences and Disorders agreed. There was a Swanson/Croxall motion/second to approve this revision of the minutes. The motion passed.

New Business

Office of Teacher Services - CEBS

- Report from the Admission and Retention Subcommittee –regarding an appeal by one student who had been denied admission to the Professional Education Unit. Janet Applin spoke about this and said the subcommittee recommended an exception be made in this student’s case. The Council members accepted the subcommittee’s recommendation.

- Candidates Completing Requirements for Admission to the Professional Education Unit August 15, 2013 to September 11, 2013. Fred Carter presented and made a motion to approve the list, seconded by Carl Myers. The motion passed.

Dr. Carter also mentioned that there will be thirtyone international students teachers going to five different countries on November 10.

School of Teacher Education

It was agreed to address the following four proposals together:

- Revise Course Prerequisites/Corequisites – EDU 701, Teacher Leadership and Assessment I
 - Revise Course Prerequisites/Corequisites – EDU 702, Teacher Leadership and Assessment II
 - Revise course Prerequisites/Corequisites – IED 703, Equity Pedagogy and Issues of Diversity
 - Revise Course Prerequisites/Corequisites – IED 704, Leadership and the Ethics of Teaching
- There was a Carter/Kirby motion to approve/second. Janet Applin explained that these courses were designed mainly for Educational Leadership Doctoral Program students and the prerequisite of admission to the Doctoral program or admission of instructor was being added. The motion passed.

▪Revise a Program – LTCY 044, Literacy Education

There was as Myers/Bland motion to approve/second. Tadayuki Suzuki explained that there was one correction of a typographical error discovered in MAE-Literacy Education degree program Specialization component. The motion passed.

Educational Leadership Doctoral (EdD) Program

▪Review a Program – 0010 Educational Leadership (EDD)

There was a Myers/McDaniel motion to approve/second. Janet Applin explained that this was to revise program admission policy with respect to GRE/GAP scores and additional requirements for international students. The motion passed.

Potter College of Arts and Letters

Department of Communication

It was agreed to address the following three proposals together:

- Revise Course Prerequisites/Corequisites – COMM 721, Organizational Communication for Leaders
- Revise Course Prerequisites/Corequisites – COMM 731, Global Communication for Leaders
- Revise Course Prerequisites/Corequisites – COMM 7511, Strategic Communication

There was a Houchens/Bland motion to approve/second. Janet Applin presented these stating that the proposed changes bring old language in the catalog up to date with revisions in the Educational Leadership Doctoral Program. There was a friendly amendment to drop the CR: None on #3 of COMM 751. The motion passed.

Other Business

The Kentucky Vanguard Project - Dr. Evans talked in depth about this.

Dr. Evans distributed the book – *Surpass Shanghai: An Agenda for American Education Built on the World's Leading Systems* as it relates to the Vanguard Project.
