### **APPENDIX D**

### RCAP RETURN ON INVESTMENT BY COLLEGE: FY11-18

The following data reflects the percentage of Category I awards (which required a follow-on extramural proposal submission) within each college, in comparison to Category II or Category III awards. For example, 87% of the RCAP awards made to OCSE during FY11-18 were in Category I and 13% were in other categories, which are not required to submit a proposal for extramural funding as an outcome of funding.

The data also reflects the return on investment (ROI) of each college's extramural awards as a result of RCAP funding. For example, for CHHS, the amount of extramural funding that was awarded back to the university as a result of RCAP funding is 434% of the total amount of RCAP funding (all categories) awarded to CHHS. The ROI is calculated by dividing extramural award amounts by the total RCAP funding received by a college.

- (d) ROI does not reflect the percentage of extramural proposal dollars requested, only the amount awarded and verified.






### Research and Creative Activities Program (RCAP) FY11-18 Outcome Report

RCAP funding is provided by the Office of Research and Creative Activity to encourage eligible full-time faculty and instructors at all WKU campuses to develop individual projects for research, scholarly pursuits, and creative activities, while promoting the pursuit of external funding sources.

Category I funds are considered "seed" monies to enhance the competitiveness of a subsequent proposal submission for external funding. Category I awardees are required to submit a proposal for extramural funding as an outcome of funding.

Category II funds support the general development, expansion, or enhancement of faculty research and scholarly activity, and/or the creative and performing arts.

The following report summarizes the outcomes and return on investment for RCAP Fiscal Years 2011-2018. During the reported period, 241 projects received RCAP funding totaling nearly \$2.26 million dollars.


### I. Outcomes

Extramural Proposals & Awards — While submission of extramural proposals is a requirement of Category I awards, all awardees may choose to submit subsequent funding requests to external sponsors. Several projects during the reporting period served as seed funding for subsequent external proposal submissions. Of the 259 external proposals submitted as a result of RCAP funding, 78 received funding. The amount of external funding received by WKU as a result of RCAP FY11-18 support is \$7,029,247.

**Student Engagement** – RCAP guidelines promote that, "all projects should aim to incorporate undergraduate and/or graduate students..." As a result of RCAP support (both directly and indirectly), 738 students gained valuable experience in research, creative activities, and other scholarly pursuits.

Publications – Most RCAP awards result in a publication of some form. During the reported period, 173 journal articles and 11 manuscripts were published as a result of RCAP funding.

Other Outcomes – RCAP projects resulted in 480 presentations\*, 267 posters\*, and 144 creative works. Additionally, RCAP projects added 8 books to departmental/library resources and added 96 pieces of small and large equipment to the university's infrastructure.



\*Reported presentations and posters refer to <u>external</u> conferences/events for both faculty and students that worked on RCAP supported projects. Presentations and posters at WKU's Student Research Conference <u>are not</u> included in RCAP Outcomes reporting.






### II. Return on Investment

The primary purpose of RCAP Category I funds are to serve as "seed" monies to enhance the competitiveness of a subsequent proposal submission for external funding. Such funding serves to provide preliminary data, proof of concept, project/fund management experience, publications, etc., all of which contribute to strengthening external proposal submissions from WKU.

During the reporting period (FY11-FY18), RCAP support totaled \$2,257,666. This reflects WKU's investment in research, scholarly endeavors, and creative activities via the RCAP program. As a result of RCAP funding, 78 external grants were awarded totaling \$7,029,247. This 311% return on investment clearly demonstrates the value of RCAP funding in stimulating competitive external proposals.



\*Note: FY15 was an off-cycle with only special request awards and in FY18 (and later rounds) RCAP instituted stricter eligibility requirements.
