Bill 10-22-S. Fall Organizational Aid Funding for \$4,950

PURPOSE: For the Student Government Association of Western Kentucky University to allocate \$4,950 from Organizational Aid for Stepping Out of Faith Miracle Life Campus Ministry, Western Kentucky University Chinese Music Club, Women in Business, Delta Sigma Theta Sorority Inc., Delta Sigma Pi, Beta Phi Chapter of Phi Sigma Pi National Honor Fraternity, Alpha Kappa Psi Professional Co-ed Business Fraternity Inc., Black Women of Western, Business Association for Development, and Western Kentucky University Habitat for Humanity.

WHEREAS: Business Association for Development will be allocated \$500 to cover the cost of polos, the printing of promotional flyers, and other miscellaneous expenses their organization will incur throughout their process of expanding their network of events that connect current students to professionals within the business field, and

WHEREAS: Black Women of Western will be allocated \$250 to cover the cost of social events that they plan to host throughout the Spring Semester intended to educate and celebrate the accomplishments of women, and

WHEREAS: Alpha Kappa Psi Professional Co-ed Business Fraternity Inc. will be allocated \$500 to cover the cost of purchasing materials needed for future professional, social, and service events that their organization plans to host throughout the Spring Semester, and

WHEREAS: Beta Phi Chapter of Phi Sigma Pi National Honor Fraternity will be allocated \$500 to cover the cost of sending a delegate to their national convention that will be hosted in Washington, D.C. on July 27, 2022, and

WHEREAS: Delta Sigma Pi will be allocated \$500 to cover the cost of sending five members to the national LEAD conference that will be hosted in Raleigh, North Carolina on February 11, 2022, and

WHEREAS: Delta Sigma Theta Sorority Inc. will be allocated \$500 towards their chapter's efforts to host and participate in professional development events for members during the Spring Semester, and

WHEREAS: Women in Business will be allocated \$200 that will be used to purchase a standing banner that their organization will use for recruiting purposes as well as for the purchasing of buttons and stickers, and
